

Sub: TDS credit to CWC Customers.

Customers who are doing business with CWC at more than one location and are submitting consolidated TDS certificate, may kindly note:-

- 1) TDS certificate should be submitted in original.
- 2) Region-wise billing details and region-wise TDS details should be enclosed with the TDS certificates in format-I. This format should be enclosed even if customer is doing business with ICD-PPG alone so as to enable this office to reconcile invoice-wise TDS for processing the refund to the customer at the earliest.
- 3) TDS refund will be processed by CWC only if the amount is appearing in 26AS statement of CWC, for this customers should ensure timely and correct filing of TDS returns.
- 4) TDS certificates should be downloaded from TRACES portal.
- 5) TDS Certificates should be accompanied by declaration from the customer to the effect that the customer will not claim refund from any other region (specimen copy of declaration is given at Format-I).

Customers are requested to adhere to above instructions to avoid delay in credit/refund of TDS amount.
