TRADE NOTICE

All EXIM users viz. Shipping Lines/Forwarders/Consolidators/NVOCC/ CHA are hereby informed that as per the approval of Competent Authority, the storage/ ground rent and miscellaneous services tariff of ICD-Patparganj is hereby revised w.e.f. 01.04.2023.

Few of the charges that have been reduced/rationalized in view of the requests received from the trade:-

- 1. <u>On Import LCL storage charges</u>: The 50% storage surcharge levied on storage beyond 06th week has been removed.
- On Import Loaded Containers: The Ground Rent Loaded charges on Import loaded containers from 16th days onwards has been made flat Rs.1000 per TEU per day removing two slab of 16th-30th day of Rs.1100 per TEU per day and 31st days onwards Rs.1650 per TEU per day.
- 3. <u>Export Container Stuffing</u>: a) Ten free days will be given to empty containers used in export stuffing.

b) After, ten free days ground rent will be charged at concessional rate of Rs. 20 per day/per TEU on those containers which will be used in export stuffing.

4. <u>Export Cargo Carting in general space</u>:- Three free days will be given for export cargo carting in godowns for cargo that utilizes area general space.

5. <u>Palletization/repacking etc</u> :- The Palletization/repacking etc. charges has been restricted to a maximum of Rs.1200 per TEU and Rs.2400 per FEU.

The Rail Haulage/Transportation and other charges for handling and transportation shall remain unchanged
